NATIONAL MOTH A FOILS AND ONEFLY

SOCIETE DES REGATES DE SAINT-PIERRE QUIBERON GRADE 4 – 17/08/2023 to 20/08/2023 – ENVSN

Preamble

1°. Prevention of violence and incivilities

The FFVoile reminds that sporting events are above all a space for exchange and sharing open and accessible to all.

As such, competitors and their legal representatives and their guests are asked to behave in all circumstances, ashore and on the water, in a courteous and respectful manner regardless of the origin, gender or sexual orientation of other participants.

2°. Following the aggression of Ukraine, the FFVoile decided on March 2, 2022 not to authorize the participation of Russian and Belarusian competitors in competitions throughout France.

The notation [NP] in a *rule* means that a boat cannot protest (No protest) against another boat when infringing this *rule*. This changes RRS 60.1(a).

The notation [DP] in a *rule* means that the penalty for a breach of that *rule* may, at the discretion of the protest committee, be less than disqualification..

1. RULES

The Regatta is governed by:

- 1.1 the rules as defined in *The Racing Rules of Sailing*,
- 1.2 National prescriptions, translated for non-French speaking competitors, in the appendix named "prescriptions" at the end of this document.
- 1.3 FFVoile regulations
- 1.4 Class rules
- 1.5 When this notice of race is translated, the French text will prevail.

2. SAILING INSTRUCTIONS (SIs)

- 2.1 The SIs will be available after 19H00 on the 16th of august, at the latest, on the SRSP website.
- 2.2 The SIs will be posted according to FFVoile prescription
- 2.3 The SIs will be available in digital version at following web address <http://www.srsp.fr/regates/index.html>

3. COMMUNICATION

- 3.1 The official online information board is available at: <http://www.srsp.fr/regates/index.html>
- 3.2 [DP] [NP] Except in an emergency, a vessel shall not transmit nor receive voice or data communication that is not available to all vessels.

4. ELIGIBILITY AND ENTRY

- 4.1 The regatta is open to all boats from the classes MAF – Moth à foils and ONEFLY
- 4.1
- 4.2 Documents required upon registration:
 - 4.2.1 a) For competitors who hold FFVoile Club license:
 - The license must show the "Competition" status (which confirms the medical ability for racing in competition).

- if the license shows either “Adhésion” or “Pratiquant” status, the competitor is requested to present a medical certificate of non-contraindication to the practice of sailing in competition dating back less than one year. If the competitor is under 18, a questionnaire related to the health condition is enough

b) For competitors who do not hold a FFVoile Club license, regardless of their nationality, they have to present :

- a proof of membership of a World Sailing affiliated National Authority
- a valid proof of civil liability insurance with a minimum coverage of two million Euros
 - a medical certificate of non-contraindication to the practice of sailing in competition dating back less than one year. If the competitor is under 18, a questionnaire related to the health condition is enough

4.2.2 For the sailing boat: not applicable.

4.3 Competitors and their eligible boats can register online until the morning of the 17th of August 2023.

4.5 To be considered registered for the event, a vessel must meet all registration requirements and pay all fees.

5. ENTRY FEES

5.1 The fees are as follows:

Included in the entry fee are : a welcome drinks party at the SRSP Clubhouse on the 17th of August late afternoon and racers dinner on the 19th of August.

6.1 [DP] [NP] Vessels may be required to display the advertising chosen and supplied by the organizing authority.

6.2 [DP] [NP] The organizing authority may provide race bibs that competitors are required to wear as authorized by World Sailing advertising Code.

- 10 **CLOTHES AND EQUIPMENT:** not applicable
- 11 **LOCATION:** the race area is located in the bay of Quiberon, right in front of the Kerbourgnec beach and the ENVSN. See appendix A.
12. **THE COURSES:** they will be of the built route type.
13. **PENALTY SYSTEM**
RRS 44.1 is amended to replace the Two-Turns Penalty with the One-Turn Penalty.
14. **SCORING**
- 14.1 3 races must be completed to validate the competition
- 14.2 (a) When less than 6 races have been validated, the score of a boat in a series will be the total of the scores of its races.
(b) When from 7 to 12 races have been validated, the score of a boat in a series will be the total of the scores of its races excluding its worst score
(c) When 13 races or more have been validated, the score of a boat in a series will be the total of the scores of its races excluding its two worst scores.
- 14.4 RRS A5.3 applies. Use only for a series in which the number of starting boats may vary considerably.
15. **SUPPORT BOATS**
[DP] Support boats must be identified by a white pennant.
16. **BOATS RENTED OR LENT**
[DP] [NP] A boat chartered or loaned may bear letters of nationality or a sailing number which do not comply with its class rules, provided that the race committee has approved its sailing identification before the race.
17. **PLACES AT THE PORT**
[DP] [NP] Boats must remain in their assigned space while in the boat park.
- 18 **DATA PROTECTION**
- 18.1 **Image and appearance rights :** Participating in the competition, the competitor and his legal representative authorize the OA, the FFVoile and their sponsors to use free of charge his image and his name, to show at any time (during and after the competition) static or moving pictures, films or TV recording, as well as other reproduction from himself done during the competition, and this on any support and for any use related to the promotion of their activities.
- 18.2 **Use of personal data of participants:** Participating in this competition, the competitor and his legal representatives agree to and authorize the FFVoile, its sponsors, as well as the OA to use and store, free of charge, his personal data. These data may be published by FFVoile and its sponsors. The FFVoile mainly, but also its sponsors may use these data for the development of softwares or with marketing purposes. In accordance with the « Règlement Général sur la Protection des Données (RGPD) » (General Data Protection Regulation (GDPR)), any competitor having transmitted his personal data to the FFVoile, may exercise his right to access to his own data, have them modified, and, depending on the situations, have them deleted, limited, or to object them, sending an email to dpo@ffvoile.fr or a letter to the Head Office of the Fédération Française de Voile, mentioning that the request is related to personal data.
19. **RECOGNITION OF RISKS**
RRS 3 mentions: « The responsibility for a boat's decision to participate in a race or to continue *racing* is hers alone. » Participating in this event, each competitor agrees and acknowledge the fact that sailing is potentially a dangerous activity with specific risks. These risks include strong winds and rough sea, sudden changes of weather conditions, failure of equipment, mistakes in boat handling, bad navigation of other boats, loss of balance on unstable surface, and causing increased risk of injury. The risk of material and/or physical damage is therefore inherent in the sport of sailing.

APPENDIX “NATIONAL PRESCRIPTIONS”

FFVoile Prescriptions to RRS 2021-2024
translated for non-French speaking competitors

FFVoile Prescription to **RRS 25.1** (*Notice of race, sailing instructions and signals*):

For events graded 4 and 5, standard notices of race and sailing instructions including the specificities of the event shall be used. Events graded 4 may have dispensation for such requirement, after receipt of FFVoile approval, received before the notice of race has been published.

For events graded 5, posting of sailing instructions will be considered as meeting the requirements of RRS 25.1 application.

(*) FFVoile Prescription to **RRS 64.4** (*Decisions on protests concerning class rules*):

The protest committee may ask the parties to the protest, prior to checking procedures, a deposit covering the cost of checking arising from a protest concerning class rules.

(*) FFVoile Prescription to **RRS 67** (*Damages*):

Any question or request related to damages arising from an incident occurred while a boat was bound by the Racing Rules of Sailing depends on the appropriate courts and cannot be examined and dealt by a protest committee.

A boat that retires from a race or accepts a penalty does not, by that such action, admit liability for damages.

(*) FFVoile Prescription to **RRS 70.5** (*Appeals and requests to a national authority*):

The denial of the right of appeal is subject to the written approval of the Fédération Française de Voile, received before publishing the notice of race. This approval shall be posted on the official notice board during the event.

(*) FFVoile Prescription to **RRS 76.1** (*Exclusion of boats or competitors*):

An organizing authority or race committee shall not reject or cancel the entry of a boat or exclude a competitor eligible under the notice of race and sailing instructions for an arbitrary reason.

(*) FFVoile Prescription to **RRS 78.1** (*Compliance with class rules; certificates*):

The boat's owner or other person in charge shall, under his sole responsibility, make sure moreover that his boat complies with the equipment and security rules required by the laws, by-laws and regulations of the Administration.

(*) FFVoile Prescription to **RRS 86.3** (*Changes to the racing rules*):

An organizing authority wishing to change a rule listed in RRS 86.1(a) in order to develop or test new rules shall first submit the changes to the FFVoile, in order to obtain its written approval and shall report the results to FFVoile after the event. Such approval shall be mentioned in the notice of race and in the sailing instructions and shall be posted on the official notice board during the event.

(*) FFVoile Prescription to **RRS 88.2** (*Changes to prescriptions*):

Prescriptions of the FFVoile shall not be changed in the notice of race and sailing instructions, except for events for which an international jury has been appointed.

In such case, the prescriptions marked with an asterisk (*) shall not be changed in the notice of race and sailing instructions. (The official translation of the prescriptions, downloadable on the FFVoile website www.ffvoile.fr, shall be the only translation used to comply with RRS 90.2(b)).

(*) FFVoile Prescription to **RRS 91(b)** (*Protest committee*):

The appointment of an international jury meeting the requirements of Appendix N is subject to prior written approval of the Fédération Française de Voile. Such approval shall be posted on the official notice board during the event.
